**PUBLIC NOTICE FOR PUBLIC HEARING
2021 ANNUAL ACTION PLAN**

The Puerto Rico Department of Housing (PRDoH), following the provisions of the Federal Laws related to the U.S. Department of Housing and Urban Development (HUD), is in the process of preparing the Action Plan for the year 2021. The Annual Action Plan integrate the use of federal funds from the Community Development Block Grant (CDBG), "Home Investment Partnerships Program" (HOME), "Housing Trust Fund" (HTF), "Housing Opportunities for Persons with AIDS (HOPWA) and" Emergency Solutions Grant "(ESG) programs. These funds are used in projects and activities that mainly benefit low- and moderate-income residents of the non-entitlement municipalities (less than 50,000 inhabitants) and other special populations around the Island.

As of the date of publication of this notice, the Department of Housing and Urban Development has not officially notified the funds allocated for the 2021 Program year, which ranges from July 1, 2021 to June 30, 2022. Therefore, for the purposes of consolidated planning processes, the allocation received in year 2020 is being used as a reference. These funds are available to meet the needs of housing, community development, economic development, social services, and public service, through the different programs, as follows:

Emergency Solutions Grant Program (ESG)</p> <p><u>Agency:</u> Puerto Rico Department of the Family</p> <p><u>Approximate amount:</u> \$3,618,910</p> <p><u>Activities:</u> Outreach services to the homeless population, emergency shelter services, housing relocation and stabilization, prevention, HMIS "Homeless Management Information System" and administration.</p> <p><u>Beneficiaries:</u> persons who are homeless and at risk of homelessness.</p>	<p>4. Home Investment Partnerships Program (HOME)</p> <p><u>Agency:</u> Puerto Rico Housing Finance Authority</p> <p><u>Approximate amount:</u> \$13,333,944</p> <p><u>Activities:</u> Rehabilitation or new construction of housing for rent, direct assistance to the buyer, rehabilitation, or new construction of housing by the owner and development of affordable housing through the participation of community housing development organizations (CHDO). The objective of these funds is the development of viable urban communities, providing adequate housing and facilities and expanding economic opportunities for persons with low and moderate incomes and other special populations. The participation of local government units, citizens, non-profit organizations, private civic entities, and government agencies in the process of identification of needs and development and implementation of the above-mentioned Plan will be encouraged.



In order to discuss the aforementioned objective and obtain input on needs and priorities, mayors of municipalities, municipal officials, public agencies, organizations with and without profit and the general public are invited to the Public Hearing in a Virtual/Telematics way.

The PRDoH will be conducting the Virtual/Telematics Public Hearing on **Friday, March 5, 2021, at 9:00 am** to discuss the proposed activities and distribution method for the aforementioned Programs. People interested in participating in the View will be able to connect through the *Teams* platform in the link that will then be notified to them.

Written comments will be accepted via email at the following address: cdbg-municipal@vivienda.pr.gov. Comments received after the designated period in this notice will not be considered.

Citizens, municipalities, and entities interested in providing comments related to the public hearing will have 30 calendar days from this publication. Comments will not be accepted after Monday, **April 5, 2021**. This notice is published in accordance with Title 24 of the Code of Federal Rules, Part 91-115.
